THE PRESIDENTIAL ADDRESS

In Real Estate they have a saying that the three most important things involving a piece of property are location, location, location. The same or something similar can be said about land work but with a slight twist. The mantra that we as landmen should subscribe too is "The three most important things in land work are landowner, landowner, landowner".

We often get caught up in title curative, leasing, and pipeline right of ways and sometimes forget about the landowner. While we are confronted on a daily basis with problems involving all of the various facets of land work, most if not all are easily fixed through negotiations or some method of legal action.

An unhappy landowner can cause problems that may not be so easily fixed. With that in mind we should make every effort to keep our relationship with the landowner on solid ground. To accomplish this we need to ensure that the landowner is involved as early in the process as possible, in any activities planned on their property.

In the drilling of a well we should be in contact with the landowner prior to any company employee or contractor entering upon the property. This can be done by phone, a personal visit and in the extreme through Certified Mail with return receipt. The contact should afford the landowner the opportunity to meet with the landman prior to any field visits, surveying or any other pre-disturbance work.

When making the initial contact, make the landowner feel involved and a part of the process. Clearly explain to them what your plans involve. Listen to their comments and concerns and incorporate some of their thoughts if it does not significantly alter your plan.

While many landowner negotiations can be trying and somewhat lengthy we will usually be successful in our dealings if we are upfront, informative and honest. You should also remember to run your plan through the "I test" before your start. The "I test" being the process of asking yourself if I owned the property in question would I be agreeable with the proposed plan. Hopefully you will be able to answer yes

and move forward with the initial landowner contract. If you cannot in good conscience approve of the proposal, you should re-evaluate the plan and construct one that is acceptable to you, then move forward.

And don't ever forget that the best landowners are happy landowners.

REGIONAL DIRECTOR'S REPORT

The AAPL Board of Directors Meeting was held on December 5th, 2010 at the Park Hyatt Aviara Resort in Carlsbad, CA. Below is a summary of meeting highlights.

<u>Treasurer's Report</u>: The AAPL balance sheet, as compared to the September 30, 2009 report, total assets have increased from \$15,267,352 to \$18,347,628, an increase of \$3,080,276 or 20.2%. The AAPL Education Foundation reports total assets of \$2,555,354, and the Landman Scholarship Trust reports total assets of \$1,414,631. The AAPL continues to be in sound financial health.

<u>New AAPL Director of Education</u>: The AAPL is pleased to announce the hiring of Christopher Halaszynski to replace Richard Rosprim as AAPL's Director of Education. Christopher has a strong background in corporate education and adult training and will be a valuable asset to the AAPL management team.

<u>New Committees:</u> A Policy/By-Law Review Committee has been formed to redraft and expand the current by-laws. Michael Curry is the Chairman of this Committee and MLBC's Arnie Schulberg is one of the Committee members.

A Website/IT Committee has been formed to create a new AAPL website. Randy Nichols is the Chairman of this Committee

<u>Summer NAPE 2010:</u> Robin Forte' was pleased to announce 5,718 persons attended Summer NAPE 2010, an increase of 4% from the previous year. 622 booths were sold, a decrease in 4% from the previous year. Net Income was 1.28 million, an increase of 4% from previous year. The net income apportioned to AAPL was \$640,284, plus \$266,653 in management fees.

<u>NAPE 2011</u>: NAPE will be held on February 16-18, 2011 at the George Brown Convention Center in Houston, TX. Approximately 1200 booths have been sold to date. The deadline for registration is February 3, 2011. There will be a full day conference on February 16 in addition to the International Forum. The Conference will feature Southwestern Energy President and CEO Steve Mueller delivering the keynote address. In addition, Shell President John Hofmeister will provide executive editorial. Country vocalist LeAnn Rimes will perform at the Heroes Luncheon where NAPE will feature presentations of cost-free homes to wounded soldiers. Discounted tickets will also be available for the Houston Rockets vs. Philadelphia 76ers at the nearby Convention Center.

<u>Awards Committee:</u> Entries for the 2011 Awards program must be submitted to AAPL no later than January 28, 2011. In the event the MLBC has any members who have performed in an exemplary manner during the past year, please contact any MLBC Officer to coordinate the nomination process. Awards are commonly given for Lifetime Achievement, Landman of the Year, Local Association of the Year, Best Newsletter/Bulletin, Best Member Communication, Best AAPL Director's Communication, Best Published Article in AAPL Publication and Special Awards (i.e.: Education, Committee Member, Community Service).
