# THE PRESIDENTIAL ADDRESS

Last month I spoke about the importance of prioritizing one's tasks. While prioritizing one's tasks is important, it only takes problem solving to a basic level. The real work comes down to details. The detailing of a task that is often repeated, like the formation of a Drilling/Production Unit, can be simplified by standardizing the procedure.

To develop a procedure for standardizing a task, you must first logically think your way through the steps involved. Once you have thought through the procedure, you then need to reduce your thoughts to a draft outline. The draft outline should attempt to identify the basic steps in the procedure. Next, you will need to provide particular detail to each basic component of the procedure. When detailing the procedure, get specific and identify each individual aspect of that part of the procedure. In some cases it may be a good idea to develop a checklist to ensure that you don't miss a step. Often times the development of a form is helpful. The form should have headers for all of the information you will need when working through a procedure. The development of your procedure is not the end of the standardization process. Periodic reviews of your processes are necessary to fine tune your procedure and adjust for regulatory changes that may have occurred.

While this may seem too basic, I believe that consistency in how we approach a recurring task is the key to accomplishing the task in a more efficient manner. Standardization is also helpful when training new employees. Providing a new employee with your organization's way of accomplishing a task will shorten the learning curve and produce productive, consistent employees more quickly.

So if you don't already have well defined ways of accomplishing recurring tasks, take the time to develop them. I think the effort you put into the development of the procedure will make you a more efficient, effective and ultimately a more valuable landman, and remember a little extra work now can make your life less stressful and more productive in the future.

# The Basics of GIS by Rico Gazal THE MLBC PRESENTS THE BASICS OF GIS BY RICO GAZAL AND CHAPTER MEETING

The boom in the oil and gas industry is accompanied by the need to produce sophisticated maps to accurately depict geographical data. Available software to perform Geographic Information System (GIS) is costly and may not necessarily be available. The ArcExplorer Java Edition for Education (AEJEE), developed by ESRI and originally designed for use in elementary and high school classroom, is a free software and available for download at: <a href="http://edcommunity.esri.com/software/aejee/">http://edcommunity.esri.com/software/aejee/</a>. AEJEE is very similar in basic operations to the full ArcGIS software.

As described in ESRI's website, ArcExplorer Java Edition for Education (AEJEE) is a downloadable, lightweight GIS tool for exploring geographic data. AEJEE can save and open projects, so work can be shared between users, or between school and home. AEJEE can classify and symbolize shapefiles, integrate a wide array of image data, project on-the-fly shapefiles stored in decimal degree, and use data distributed over the Internet <a href="https://example.com/napwv.gov">https://example.com/napwv.gov</a> for West Virginia and <a href="http://maps.pasda.psu.edu">http://maps.pasda.psu.edu</a> for Pennsylvania). ESRI has also its own list of ArcIMS sites at <a href="http://edcommunity.esri.com/data/arcims/">http://edcommunity.esri.com/data/arcims/</a>.

The seminar on Basics of GIS sponsored by MLBC: Association of Professional Landmen will be held in Charleston, WV at the Marriott Hotel on November 10, 2010. This course will introduce basic concepts of GIS and also explore the basics of preparing maps using ESRI's ArcExplorer Java Edition for Education (AEJEE). The seminar will be lead by Dr. Rico M. #### Pennsylvania Orders Moratorium on Oil and Gas Leases in State Forests

Pennsylvania Governor Edward G. Rendell has signed an executive order banning future oil and gas leasing of lands owned or managed by the Department of Conservation and Natural Resources (DCNR). Governor Rendell's order does not affect existing leases on state forest land, but it does prohibit any further leasing of the 2.2 million acres of forest owned or managed by the DCNR. Since 2008, Pennsylvania has generated \$4.5 million in royalties from leases on approximately 700,000 acres of state land overlying the gas-rich Marcellus shale formation.

State-owned lands cover less than 10 percent of the Marcellus formation in Pennsylvania, according to Terry Engelder, a Pennsylvania State University geologist. While there are only about 20 wells currently producing gas from the Marcellus formation on state property, that number could grow to as many as 12,000 wells over the next 20 years under existing leases, according to the Department of Conservation and Natural Resources.

According to Governor Rendell, the order was in response to the state Senate's failure to act on House Bill 2235, which would have instituted a similar moratorium on leasing of state forest lands. Depending on the outcome of the upcoming election, the moratorium could be lifted as early as January. The Republican candidate for governor, Attorney General Tom Corbett, has indicated he is opposed to a moratorium, while his opponent, Democrat Dan Onorato, supports it.
